In his twenty plus years of practice, Jason has first-chaired more than seventy-five (75) civil and administrative trials and private arbitrations throughout the country through decision and second-chaired many others, often in large-scale, complex cases involving multiple parties, numerous expert and fact witnesses, and novel legal and factual issues. Jason has examined and cross-examined hundreds of fact and expert witnesses at trial and many more in depositions. He also has been both a trial and appeal consultant.

Jason has significant experience in a variety of commercial and business disputes, complex contract cases, class actions (involving unfair and deceptive business practices and consumer fraud), real estate, land use, construction and development, industrial and mining accidents, catastrophic events, mass torts, mine safety (MSHA, FMSHRC), occupational safety (OSHA, UOSH, Cal/OSHA), and defective products and warranty claims.

In 2020, helped obtain a temporary restraining order and preliminary injunction in Utah state court for Rocky Mountain Power against numerous landowners in South Jordan, Utah, requiring the landowners to allow the utility to enter upon an easement for pre-construction and construction activities related to a transmission line project. (Civil No. 200901449.)

In 2019, as lead counsel, obtained complete summary judgment for Bombardier, Inc., one of the world's largest aircraft manufacturers, in a complex commercial contract dispute concerning a claim against Bombardier for over \$3 million in allegedly due residual value payments (plus interest) in Utah federal district court. In 2019, as lead counsel, successfully resolved a complex easement dispute involving the current and former owners of the Winder Farms Dairy and addressed numerous environmental and water rights issues in the process.

In 2019, oversaw and coordinated months long negotiations and closing of the complex sale of a large Utah and Idaho based company with numerous locations throughout both states and resolved a variety of environmental, land use, and real estate issues in the process.

In 2018, as lead counsel, Jason won an important appeal before the Federal Mine Safety and Health Review Commission (the FMSHRC) involving a fight between the FMSHRC, the Mine Safety and Health Administration (MSHA), and the United Mine Workers Association over the FMSHRC's settlement approval process and in the process helped set administrative policy. (Reported at 40 FMSHRC 983 (Aug. 2018).)

In 2018, as lead counsel, Jason won a complex civil penalty case on behalf of a large mine operator following an administrative trial against MSHA, which

resulted in a groundbreaking, widely recognized decision that deleted MSHA's severe, rarely used flagrant designation and also resulted in an extremely large reduction in civil penalties. (Reported at 40 FMSHRC 1234 (July 30, 2018).)

In 2015, as co-lead counsel, Jason successfully represented as plaintiffs a nationwide class of former Herbalife distributors in a complex class action against Herbalife International, Inc., alleging claims of unfair and deceptive business practices, false advertising and an endless chain scheme and obtaining the widely publicized global settlement of \$17.5 million and injunctive relief. (Case No. 2:13-cv-02488-BRO-RZ Central District, California.)

Jason successfully acted as trial consultant in a complex patent licensing dispute in Utah state court in a case that resulted in favorable verdict and award of close to \$1 million in attorneys' fees from the opposing party.

As co-lead counsel, Jason successfully represented the co-owner, operator and parent entities of the Crandall Canyon Mine near Huntington, Utah in three complex civil lawsuits stemming from the multiple deaths and injuries arising out of the collapse of the Mine and failed rescue in August 2007. Jason played a key role in investigating and mastering the complex facts, in working with world renowned seismologists and rock mechanics experts, in negotiating with over 40 plaintiffs, 60 plaintiffs' counsel, and 9 insurance companies, and in reaching the highly publicized global settlement of all claims from all plaintiffs against all defendants in just 22 months following the accidents. Murray Energy Corp. et al., Civil No. 030902493, Eighth District Court, Carbon County, State of Utah; Jensen et al. v. Murray Energy Corp. et al., Civil No. 080918250, Third District Court, Salt Lake County, State of Utah.)

As lead and co-lead counsel, Jason successfully represented multiple general contractors and subcontractors in multiple AAA arbitrations in complex construction cases involving breaches of various contracts, alleged construction defects, claims for
