Jennie oversaw all of the Probate, Guardianship, Conservatorship and Minor Settlement court approvals stemming from the highly publicized global settlement of all claims against all defendants in less than two years following the accidents.

Jennie also handles real estate transactions from letter of intent through closing, and has handled several difficult real property sales and acquisitions.

Jennie has also successfully litigated cases through trial, including acting as lead counsel in a dispute between a national for-profit college and a commercial landlord. Jennie defended the college through a three-day trial relating to the interpretation of the underlying contract lease provisions and alleged damages to the leased premises. At the conclusion of the trial, the court ruled in favor of the college on its counterclaim and awarded attorney's fees and costs incurred through trial.
